ANNUAL MEMBERSHIP PROGRAMME (2022 SEASON)

Full Playing Membership

Senior - £50

Ladies Softball - £30

Student and Unemployed - £30

Youth (u16) - £30

Benefits include (but are not limited to):

- Subsidised match shirt (100% for Senior and Youth, 50% for Ladies, Student and Unemployed).
- Full voting rights at the Club's AGM including all member-voted awards. Youth members are not eligible to vote.
- Eligibility to win one of the Club's end of season awards.
- · Reduced Match Fees.
- Priority over non-members with reference to team selection.
- The option to create a payment plan with the Club's Treasurer.

Current Match Fees for Full Playing Members

Senior - £8 (£5 midweek)

Ladies Softball - £5

Youth, Student and Unemployed - £5 (£3 midweek)

(NB: Match fees are set by the Club's committee and can be altered at any point during the season)

Recreational Membership

Unlike Full Playing Members, Recreational Members will have no voting rights, no subsidised shirt, and are ineligible to win awards. Due to not paying an annual membership fee, Recreational Members would attract an increased Match Fee.

Senior - £15 per match

The increase from £12 to £15 will see £7 per match provided to the club on top of the normal match fees to cover insurance and other running costs of the Club. After 7 matches as a Recreational Member, the club will automatically consider the player to have full member status.

Ladies Softball - £8 per match

Match fee increase of £3 to £8 to cover insurance and other running costs of the Club. After 6 matches Full membership will be met.



Youth, Student and Unemployed - £10 per match

Match fees increase £5 to £10 per match. After 6 matches Full membership will be met.

Non-playing Membership

Vice Presidents - £40

Benefits include (but are not limited to):

• Full voting rights at the Club's AGM including all member-voted awards.

AWARD GUIDANCE DOCUMENT (2021)

LEAGUE SATURDAY XI AWARDS

Batting – The President's Cup

The Club makes an annual award to the player with the best batting average for the league side. The player must have played a minimum of at least 8 innings for the Saturday league side to qualify.

Bowling - The Secretary's Cup

The Club makes an annual award to the player with the best bowling average for the league side. The player must have bowled a minimum 30 overs for the Saturday league side to qualify.

Captain's Cup - The John Baxter Trophy

Chosen solely by the Captain of the league side, The Captain's Award recognises commitment, endeavour and the significant contribution by a young player over the course of the league season.

FRIENDLY XI AWARDS

Batting – The Roy Chandler Cup

The Club makes an annual award to the player with the best batting average for the friendly side. The player must have played a minimum of at least 8 innings in non-league games.

Bowling - Hiscock Electrical Trophy

The Club makes an annual award to the player with the best bowling average for the friendly side. The player must have bowled a minimum 30 overs in non-league games.

COMBINED LEAGUE/FRIENDLY AWARDS

Fielding - Comrades Shield

The Club makes an annual award to the player (excluding wicket keepers) that takes the most catches during the season in league and friendly games.

Ducks – The Bronze Duck

The Club makes an annual award to the player that collects the most ducks during the season in league and friendly games.

Sixes - The 'Holey' Bat

The Club makes an annual award to the player that hits the most sixes during the season in league and friendly games.

DEVELOPMENT XI AWARDS

Batting

The Club makes an annual award to the player that has scored the most runs for the Development XI side. The player must be Under 18 to qualify.

Bowling

The Club makes an annual award to the player that has taken the most wickets for the Development XI side. The player must be Under 18 to qualify.

Fielding

The Club makes an annual award to the player that has the greatest cumulative total of catches, run outs and stumpings for the Development XI side. The player must be Under 18 to qualify.

SPECIAL PRESENTATIONS

Club Person of the Year - Peter Gordon Cup

The Club makes an annual award to the person who contributes most to the Club on and/or off the field during the course of the season. This award is determined via a ballot of Club Members, and the winner is the individual that receives the greatest number of votes.



Outstanding Young Player – The Young Player Shield

The Club makes an annual award to the outstanding young player during the course of the season. To qualify for this award, players are required to be under 18 and have played in a minimum of five league, friendly or Development XI matches during the season. This award is determined via a ballot of Club Members, and the winner is the individual that receives the greatest number of votes.

Best Individual Batting Performance – Gordon Mackrell Memorial Batting Shield

The Club recognises the most distinguished single batting performance by a player within any match during the course of the season. This award is adjudicated by the Club's Committee.

Best Individual Bowling Performance – Gordon Mackrell Memorial Bowling Shield

The Club recognises the most distinguished single bowling performance by a player within any match during the course of the season. This award is adjudicated by the Club's Committee.

Club Caps

The Club awards playing caps to Club Members who either score 50 runs or take five wickets in a single innings of a full senior game. In addition, the Club shall award Captain's Merit Caps to Club Members in recognition of their services to the Club. In this instance Club Captains will nominate Club Members, and the Club Committee shall approve the award.

NOTES

- The Club's relevant captain is responsible for ensuring each scorebook is correctly entered onto the Club's play-cricket website. The play-cricket site details will be deemed definitive and the end-ofseason statistics are produced from this.
- The President's XI match is officially regarded as an external game for the Club, and all Collingbourne players will have their figures count towards the friendly statistics/averages.
- 3. Any Collingbourne members asked to play for the opposition on any match day will have his/her match figures added to the Club's relevant annual averages and al- time tallies.
- 4. Intra-club games do not count towards the Club's annual averages and all-time tallies, unless agreed by the Captains and Club Secretary beforehand.
- 5. Development XI statistics remain separate from the friendly statistics (because not all players are eligible to play), but do contribute to the all-time runs/wickets tally for the Club (as the opposition are predominantly senior players). The Development XI team will have its own batting, bowling and fielding averages and respective awards. Development XI figures do not contribute towards the Sixes, Catches or Duck awards.
- 6. Presentation of awards is subject to the recipient having paid their annual subscription for the current season in full, and no match fees being overdue.
- 7. Any player-initiated grievances should be dealt with in the first instance by the relevant captain. If appropriate, the captain can escalate the issue to committee level for advice and a final ruling.



Collingbourne Cricket Club PLAYER SELECTION POLICY (2021)

The purpose of this document is to act as guidance for captains and players, and provide a fair and transparent process to team selection.

Although Collingbourne Cricket Club welcomes new and recreational players, it has a responsibility to ensure its fully paid-up members take priority over those that are not. Both youth and adult members will be treated equally. However, selection will be based on ensuring all members have an opportunity to play as many games as possible. For example, Senior members will be prioritised for Senior matches over Youth members, as they will have their own matches which Seniors cannot partake in.

For full details on the Club's membership options, please refer to the Club's Annual Membership Programme document.

The club will always try to ensure that members that make themselves available are accommodated and given at least one game over a weekend. Therefore, a player who has declared their availability for two days over a weekend may not necessarily be asked to play on both days but will play at least one.

As has always been the case, it is the player's responsibility to give their availability to the Club's captains in a timely manner. In order to minimise confusion, availability should be clear and concise with little open to interpretation.

Over Capacity

In the event of there being more than eleven players available for a game in the Senior section, then the following guidelines will be followed:

Saturday – Club members take priority over non-members in the first instance. If more than eleven club members are available, and no other solution can be found (eg. a player moving to Sunday), then the captain will pick the best XI for playing and attempting to win that game.

Sunday - Club members take priority over non-members in the first instance. If more than eleven members are available, and no other solution can be found (eg. a player moving to Saturday or a midweek game), players will be used in rotation by the captain to ensure all members are given a similar number of playing opportunities. Priority will also be given to players that made themselves available for Saturday, but we're not selected.

Under capacity

Saturday league matches will take priority over Sunday friendly games. Players will be encouraged to make themselves available for Saturday wherever possible.

Players who volunteer to fill a space in a differing team and are unable to play in their preferred game will get priority for their preferred game where possible the following week.

Selection Rules for other Sections

Cavaliers Midweek - This is a segmented section with allotted spaces for development players and seniors. Although it is on invite only (as we intended for our adults to provide both the skills to ensure a competitive game and knowledge to impart on developing players) the Captain of the team will look to involve and offer as many Senior players as possible opportunities to play. The Captain may ask for availability but reserve the right to pick which player plays.

President's Match - This is a mixture of both Saturday, Sunday and midweek players and is led by the Sunday Captain. The Captain has the right to ask for availability of players and to pick a team that is a snapshot of Collingbourne as a club. This means it may not be the strongest Collingbourne side,



however, it will provide a competitive game against the President's XI which historically is a mix of legacy players and guests.

Disputes

In the first instance, Members should approach the relevant Captain(s) to discuss any selection queries they may have.

If any player believes the above processes have not been followed, then they may raise their grievance directly with the Club's Chairperson. Please do so in writing and avoid using social media or the Club's chat groups.
